CONSENT ORDER AND NOTICE OF DISMISSAL

AND NOW, this 11th day of April 2022, the parties having appeared before the Court in
this matter, the Court adopts the following mutually agreed-upon settlement terms.

1. Lancaster Township shall pay to the Reporters Committee for Freedom of the Press an amount equal to \$6,500 on or before May 11, 2022, which said amount shall be subject to Form 1099 reporting
2. No later than October 11, 2022, Lancaster Township supervisors and employees shall receive training on the Right to Know Law and agencies' obligations under the Law from a source and in a format agreeable between legal counsel for the parties.
3. The stipulated provisions of settlement do not constitute an admission of liability or violation of any federal, state, or local law or regulation on the part of the Township, its elected officials, or employees.


