PETITION FOR RELIEF FOR VIOLATIONS OF THE OKLAHOMA OPEN RECORDS ACT

Plaintiff Rebecca Nagle, by and through undersigned counsel, brings this Petition against Defendant J. Kevin Stitt in his official capacity as Governor of the State of Oklahoma and Defendant John M. O'Connor in his official capacity as Attorney General of the State of Oklahoma (collectively "Defendants") and alleges as follows:

PRELIMINARY STATEMENT

1. Nagle brings this action pursuant to Okla. Stat. tit. 51, § 24A.17(B) regarding Defendants' wrongful withholding of and failure to produce in a prompt and reasonable manner requested records of a public official and/or public body subject to disclosure under the Oklahoma Open Records Act ("ORA"), Okla. Stat. tit. 51, §§ 24A.1–24A.33.

PARTIES

A. Plaintiff Rebecca Nagle

2. Based in Tahlequah, Oklahoma, Plaintiff Rebecca Nagle ("Nagle") is an award-winning writer, audio journalist, and citizen of Cherokee Nation. Since 2018, Nagle has

provided leading coverage of issues related to *McGirt v. Oklahoma*, 140 S. Ct. 2452 (2020), the United States Supreme Court case that reaffirmed the Muscogee (Creek) Nation's treaty boundaries in Oklahoma as a present-day "Indian reservation" and resolved questions concerning criminal jurisdiction in parts of Oklahoma. Nagle's work has appeared in major publications such as The Washington Post, The Guardian, USA Today, and The Atlantic. She is also known for her chart-topping podcast This Land, which told the story of the United States Supreme Court case *Sharp v. Murphy* and won Nagle the American Mosaic Journalism Prize in 2020. *See* 140 S. Ct. 2412 (2020) (per curiam) ("*Murphy*").

- 3. Nagle is the author of the forthcoming book, *Indian Territory* (HarperCollins Publishers LLC), which expands on her earlier reporting regarding the complex legal and political issues pertaining to Native American land and Indigenous rights, including those raised by *McGirt* and other related cases such as *Murphy*.
- 4. Maddie Stone is a Research Assistant employed by Nagle for her forthcoming book, *Indian Territory* (HarperCollins Publishers LLC). During the course of Ms. Stone's employment, she drafted and submitted ORA requests on behalf of Nagle to several public officials and public bodies in Oklahoma. On multiple occasions, Ms. Stone followed up with public officials and/or public bodies regarding the ORA requests she submitted on Nagle's behalf.

B. Defendant J. Keyin Stitt

- 5. Defendant J. Kevin Stitt ("Stitt") is currently the Governor of the State of Oklahoma, an office he has held since 2019.
- 6. As Governor of Oklahoma, Stitt is a "public official" within the meaning of, and subject to, the ORA. See id. § 24A.3(4).

- 7. The Office of the Governor is a "public body" within the meaning of, and subject to, the ORA. See Okla. Stat. tit. 51, § 24A.3(2).
 - 8. Stitt's place of business as Governor is located within Oklahoma County.

C. Defendant John M. O'Connor

- 9. Defendant John M. O'Connor ("O'Connor") is currently the Attorney General of the State of Oklahoma, an office he has held since 2021.
- 10. As Attorney General of the State of Oklahoma, O'Connor is a "public official" within the meaning of, and subject to, the ORA. See id. § 24A.3(4).
- 11. The Office of the Attorney General is a "public body" within the meaning of, and subject to, the ORA. See Okla. Stat. tit. 51, § 24A.3(2).
- 12. O'Connor's place of business as Attorney General is located within Oklahoma County.

STATEMENT OF FACTS

D. McGirt—a historic ruling by the United States Supreme Court

13. The recent United States Supreme Court case *McGirt v. Oklahoma* was a historic decision for the state of Oklahoma, Muscogee (Creek) Nation, other tribal nations across the state¹, and more broadly for tribal sovereignty and treaty rights in the United States. *See* 140 S. Ct. 2452 (2020). Specifically, *McGirt* reaffirmed the Muscogee (Creek) Nation's treaty reservation boundaries and created a considerable shift in criminal prosecutions on tribal land in Oklahoma in cases involving Native Americans. *See id*.

¹ In the months following *McGirt*, Oklahoma courts extended the ruling to the Cherokee Nation, Chickasaw Nation, Choctaw Nation, Seminole Nation, and Quapaw Nation.

- 14. It is in the public interest for the events surrounding the historic Supreme Court decision, including the actions and communications of Oklahoma's public officials, to be well documented and accurately reported.
- 15. As alleged below in detail, Nagle is unlawfully being denied prompt and reasonable access by Defendants to open records pertaining to the actions and communications of public officials leading up to and following the *McGirt* decision.

E. Nagle's three Open Records Act requests to the Office of Governor Stitt

- Governor Stitt ("First Governor Request") via email for certain public records relevant to her upcoming book. Specifically, Nagle requested all email communications (including emails, email attachments, complete email chains, calendar invitations, and calendar invitation attachments) sent by certain individuals in the Office of the Governor to certain email addresses from January 1, 2017, through the date the search was conducted containing any of the specified search terms: McGirt; McGirt v. Oklahoma; Murphy; Sharp v. Murphy; Carpenter v. Murphy; One Oklahoma; Commission on Cooperative Sovereignty; and SAFETEA. A true and correct copy of Nagle's First Governor Request is attached as **Exhibit A**.
- 17. A representative of the Office of Governor Stitt acknowledged receipt of Nagle's First Governor Request via email on October 27, 2021. A true and correct copy of the acknowledgment is attached as **Exhibit B**.
- 18. As of the filing of this Petition, it has been more than a year since Nagle submitted her First Governor Request on October 22, 2021.
- 19. On December 28, 2021, Nagle sent a second ORA Request to the Office of Governor Stitt ("Second Governor Request") via email for certain public records relevant to her upcoming book. Specifically, Nagle requested all email communications (including emails,

email attachments, complete email chains, calendar invitations, and calendar invitation attachments) sent by certain individuals in the Office of the Governor to certain email addresses from January 1, 2017, through the date the search was conducted containing any of the specified search terms: McGirt; McGirt v. Oklahoma; Murphy; Sharp v. Murphy; Carpenter v. Murphy; One Oklahoma; Commission on Cooperative Sovereignty; and SAFETEA. A true and correct copy of Nagle's Second Governor Request is attached as **Exhibit C**.

- 20. A representative of the Office of Governor Stitt acknowledged receipt of Nagle's Second Governor Request via email on January 3, 2022. A true and correct copy of the acknowledgment is attached as **Exhibit D**.
- 21. As of the filing of this Petition, it has been over ten months since Nagle submitted her Second Governor Request on December 28, 2021.
- 22. On February 9, 2022, Nagle sent a third ORA Request to the Office of Governor Stitt ("Third Governor Request") via email for certain public records relevant to her upcoming book. Specifically, Nagle requested all communications (including physical letters, emails, email attachments, calendars and calendar attachments) from January 1, 2005 to December 31, 2005 and January 1, 2020 to December 31, 2020, between Oklahoma Senator James Inhofe and former Oklahoma Governor Brad Henry or current Oklahoma Governor Kevin Stitt containing one or more of specified search terms including: SAFTEA; Safe, Accountable, Flexible, Efficient Transportation Equity Act; EPA; Environmental oversight; Indian; Indian lands; Tribal; Tribal lands; Cherokee; Choctaw; Chickasaw; Muscogee; Creek; Seminole; McGirt; McGirt v. Oklahoma; Murphy; and Murphy v. Sharp. A true and correct copy of Nagle's Third Governor Request is attached as Exhibit E.

- 23. A representative of the Office of Governor Stitt acknowledged receipt of Nagle's Third Governor Request via email on February 10, 2022. A true and correct copy of the acknowledgment is attached as **Exhibit F**.
- 24. As of the filing of this Petition, it has been nearly nine months since Nagle submitted her Third Governor Request on February 9, 2022.
- 25. Nagle has contacted the Office of Governor Stitt multiple times concerning the status of her outstanding ORA requests. On at least one occasion, Nagle's counsel followed up on her behalf.
- 26. As of the filing of this Petition, the Office of Governor Stitt has not made any records available to Nagle in response to her First, Second or Third Governor Requests.

F. Nagle's Open Records Act request to the Office of Attorney General O'Connor

- 27. On or around October 22, 2021, Nagle sent an ORA Request to the Office of Attorney General O'Connor ("AG Request") via email for certain public records relevant to her upcoming book. Specifically, Nagle requested all emails including attachments between former Attorney General Mike Hunter or current Attorney General John O'Connor and certain email addresses from January 1, 2017 to October 21, 2021, containing any of the specified search terms: McGirt; McGirt v. Oklahoma; Murphy; Sharp v. Murphy; Carpenter v. Murphy; One Oklahoma; and Commission on Cooperative Sovereignty. A true and correct copy of Nagle's AG Request is attached as **Exhibit G**.
- 28. A representative of the Office of Attorney General O'Connor acknowledged receipt of Nagle's AG Request via email on October 26, 2021. A true and correct copy of the acknowledgment is attached as **Exhibit H**.
- 29. As of the filing of this Petition, it has been more than a year since Nagle submitted her AG Request on October 26, 2021.

- 30. Nagle has contacted the Office of Attorney General O'Connor multiple times concerning the status of her outstanding ORA request. On at least one occasion, Nagle's counsel followed up on her behalf.
- 31. As of the filing of this Petition, the Office of Attorney General O'Connor has not made any records available to Nagle in response to her AG Request.

CAUSES OF ACTION

Violations of the Oklahoma Open Records Act by Defendants

- 32. The purpose of the ORA is "to ensure and facilitate the public's right of access to and review of government records so they may efficiently and intelligently exercise their inherent political power." Okla. Stat. tit. 51, § 24A.2.
- 33. Accordingly, the ORA provides that "[a]ll records of public bodies and public officials shall be open to any person for inspection, copying, or mechanical reproduction during regular business hours." *Id.* § 24A.5.
- 34. "A public body must provide prompt, reasonable access to its records A delay in providing access to records shall be limited solely to the time required for preparing the requested documents and the avoidance of excessive disruptions of the public body's essential functions." *Id.* § 24A.5(6).
- 35. Disclosure of the requested records is intended to, and reasonably likely to, enable Nagle, a published author, to learn more about state government in several key areas (e.g., tribal relations, public safety, energy, etc.) and evaluate whether those entrusted with the affairs of the government are honestly, faithfully, and competently performing their duties as public servants.
- 36. Information contained in the requested records will be made public in *Indian*Territory (HarperCollins Publishers LLC), Nagle's forthcoming book that expands on her earlier reporting regarding the complex legal and political issues concerning Native American land and

Indigenous rights, including those raised by McGirt and other related cases.

37. Accordingly, disclosure of the requested records serves the public interest.

<u>COUNT ONE - Violations of the Oklahoma Open Records Act by Governor Stitt</u> and/or the Office of the Governor

- 38. Nagle repeats, realleges, and incorporates the allegations set forth in paragraphs 1 through 37 as though fully set forth herein.
- 39. The records sought by Nagle's First, Second, and Third Governor Requests are records of a public official and/or public body as defined by the ORA. Okla. Stat. tit. 51, § 24A.3.
- 40. Governor Stitt and/or the Office of the Governor possess records responsive to Nagle's First, Second, and Third Governor Requests.
- 41. There is no legal basis for the failure of Governor Stitt and/or the Office of the Governor to disclose the requested records.
- 42. Governor Stitt and/or the Office of the Governor have failed to provide prompt, reasonable access to records responsive to Nagle's three requests for public records as required by the ORA.
- 43. Governor Stitt and/or the Office of the Governor have violated the ORA by wrongfully withholding the records requested by Nagle and by failing to provide prompt, reasonable access to open records. Governor Stitt and/or the Office of the Governor will continue to be in violation of the ORA absent declaratory and injunctive relief from this Court.

<u>COUNT TWO – Violations of the Oklahoma Open Records Act by Attorney General</u> <u>O'Connor and/or the Office of the Attorney General</u>

- 44. Nagle repeats, realleges, and incorporates the allegations set forth in paragraphs 1 through 37 as though fully set forth herein.
 - 45. The records sought by Nagle's AG Request are records of a public official and/or

public body as defined by the ORA. Okla. Stat. tit. 51, § 24A.3.

- 46. Attorney General O'Connor and/or the Office of the Attorney General possess records responsive to Nagle's AG Request.
- 47. There is no legal basis for the failure of Attorney General O'Connor and/or the Office of the Attorney General to disclose the requested records.
- 48. Attorney General O'Connor and/or the Office of the Attorney General have failed to provide prompt, reasonable access to records responsive to Nagle's request for public records as required by the ORA.
- 49. Attorney General O'Connor and/or the Office of the Attorney General have violated the ORA by wrongfully withholding the records requested by Nagle and by failing to provide prompt, reasonable access to open records. Attorney General O'Connor and/or the Office of the Attorney General will continue to be in violation of the ORA absent declaratory and injunctive relief from this Court.

REQUESTED RELIEF

WHEREFORE, Nagle respectfully requests the Court enter an order:

- A. Declaring the records sought by Nagle's First, Second and Third Governor Requests and AG Request to be open records available to the public for inspection and copying in accordance with the Oklahoma Open Records Act;
- B. Declaring Defendants' failure to provide the requested records in a prompt, reasonable manner an unlawful violation of the Oklahoma Open Records Act;
- C. Requiring the immediate production of all requested records that have been improperly withheld by Defendants;
 - D. Awarding Nagle reasonable attorney's fees and the costs of this action; and

E. Granting such other and further relief as the Court deems just and proper.

Fee Waiver Request

In accordance with 51 O.S. tit. 51, § 24A.5(4), I request that your office charge no search fees in connection with processing this request for records. The subject of this request concerns the operations of the Oklahoma state government, and the disclosures will likely contribute to a better understanding of relevant government procedures by the general public in a significant way.

Specifically, the requested records have the potential to shed light on how Oklahoma's oil and gas industry has sought to influence state politics and the extent to which state politicians have solicited input from the oil and gas industry prior to, and in wake of, the July 9, 2020 Supreme Court decision in *McGirt v. Oklahoma*¹. Records with the potential to shed light on this matter would contribute significantly to public understanding of what a post-*McGirt* future looks like for Oklahoma's oil and gas industry, which employed more than 53,000 citizens in 2015 and is a major contributor to state revenues².

Knowledge obtained through this request will be made public in *Indian Territory*, a forthcoming book on *McGirt v. Oklahoma* authored by journalist Rebecca Nagle, which will be published by HarperCollins Publishers LLC in 2022³. Through her award-winning investigative podcast *This Land*⁴ and print articles written for national media outlets

including *The Atlantic*⁵ and *The Guardian*⁶, Ms. Nagle has spent years informing the public about complex legal and political issues concerning Native American land and indigenous rights, including the issues raised by *McGirt*.
