- 7. **Exhibit D** is a true and correct copy of a record I received from VDOE on October 5, 2022. Exhibit D consists in part of an email from Jillian Balow to Charles Pyle forwarding an attachment titled "Talking Points Transgender Guidance Copy.docx" (the "Talking Points" record).
- 8. VDOE did not produce the 87 records that Ms. Askew stated were withheld pursuant to Va. Code § 2.2-3705.7(2).
