THE COURT: What's the government's position regarding sentencing?

MR. MOODY: Your Honor, if I may, as we laid out in our memorandum, we think a term of incarceration of 15 months is appropriate.

I'll address the seriousness of the offense first.

Your Honor, UNAOIL was at the center of a pervasive and wide-ranging international corruption scheme. Ιt paid millions of dollars in bribes to corrupt government officials in the Middle East, Africa and Central Asia. those bribes to win foreign government contracts for itself as well as 27 multinational oil and gas companies including companies headquartered in the United States and companies listed on U.S. stock exchanges. It did this over and over again for years. In country after country, in deal after deal UNAOIL undercut fair business practice, undermined the rule of law and lined the pockets of corrupt government officials as well as their own, all at the expense of the citizens whose countries were destabilized by this corruption and were harmed by the kleptocratic officials who took Union Oil's bribes. Ultimately for UNAOIL, its clients and the corrupt officials, it was about one thing: Greed.

Mr. Ahsani was a critical part of this for 11 years. He personally negotiated and paid bribes in Libya

and he enabled the payment of other bribes negotiated by his father and older brother by setting up a complex web of shell companies and bank accounts all over the world to hide the true nature of the bribes from financial institutions and from law enforcement, none of whom could stop it because Mr. Ahsani made sure UNAOIL was always one step ahead.

And when law enforcement was finally catching up to Mr. Ahsani and his father and brother in 2016, they destroyed evidence of their crimes in an effort to obstruct justice. That's why, Your Honor, the government submits that this is profoundly serious conduct.

But, Your Honor it's not the whole story. It's just the first part. From the moment the government met Mr. Ahsani in 2019 it appeared he had undergone a transformation. From Day 1 Mr. Ahsani was all in, an open book; and without going into specifics, as described in our memorandum, he's been doing everything he possibly can for the last four years. He appears to be a person who truly regrets the bad decisions he's made, is deeply remorseful and is trying to make amends and for the past four years he has, in fact, done the right thing in an extraordinary and exemplary way and for that reason, Your Honor, balancing those two things, the government thinks a term of incarceration of 15 months is appropriate in this case.

THE COURT: All right.

#### Mr. Coggins?

MR. COGGINS: Thank you, Your Honor.

Ms. McCoy and I have represented Mr. Ahsani only a few short months now, Your Honor, and not anything near the five-plus years that he's been working with United States authorities. I have met and worked with many defendants over the years as a prosecutor and as a defense lawyer. I've never met with one who genuinely felt remorse as deeply as Mr. Ahsani does, nor have I ever worked with one who went to greater lengths to atone for his crimes. Perhaps this is because in some part he's such a different person now from the one who committed the crimes those years ago.

I would like to talk a little bit about his situation. Mr. Ahsani is a family man. He's devoted to his three young children, Elysee, Kasra and Keyvan; and although he's divorced from his wife, he continues to take care of her, as she's not able to take care of herself. Mr. Ahsani also is, with his brother, the support for aging parents, both of whom have debilitating health conditions. But despite the fact he's a family man, despite the fact that he is the sole emotional support for the kids and the support for the parents, Mr. Ahsani has spent a considerable amount of time away from his home for reasons the Court is aware of, away from his family, four months, as we've mentioned, in restrictive confinement in a small efficiency in Italy, four months where

he was not allowed to have a visitor other than his attorney, four months in which he was not allowed to leave; and that was, Your Honor, really due to an administrative oversight by the U.S. government because he was on his way over here, had been assured that everything was cleared and it didn't work out that way. It was nobody's fault. It was just an oversight, but that was four months that he had no idea what was going to happen to him or where he would go. In addition, he spent ten months here in DC.

We would submit that the Government's 15 months is met and answered by the 14 months he spent either in Italy or here in the United States. I would also like to point out that Mr. Ahsani's role in the company is a little different. The company was founded in 1991 by his father. His brother joined shortly after that. But Mr. Ahsani was busy at the time earning a degree at Oxford, with honors. He later earned an MBA from the leading business school in Europe. He worked at Goldman Sachs.

So he joined UNAOIL full-time in 2005. When he joined UNAOIL in 2005 he was not aware of the illegal activities; but he does not contest, Your Honor, the government's rendition of what he did while he was there and he knows it was wrong. Nor does he contest the forfeiture figure that the government has agreed upon.

Saman Ahsani would also like to point out that

UNAOIL was an intermediary in these bribe payments; but it was more than that, Your Honor. The father's vision for the company, which unfortunately they didn't follow that vision completely, was to basically bring western technology on infrastructure projects with local workforces; and they were able to do that. They also had a vision to contribute to charity and they set up charities that benefitted and built water filtration systems in west Africa, built schools for girls in Iran and did those kind of things. If only the company had stuck to that, but that was Sammy Ahsani's vision of what it could become. Most of the money they made, they poured back into the company. Once the investigation began, the company imploded, hundreds of workers lost their jobs and all the equity in the company disappeared.

So Sammy Ahsani had a much shorter stint in the company than others did. He had a vision of weaning the company away from these illicit payments, and unfortunately it didn't happen. But we would argue, Your Honor, that his situation is vastly different from most defendants who stand before you in the sense of the time he spent, the time he spent away from his family, the six or seven continuances the government has requested that he's acceded to; and we would argue that he also is different from most white-collar defendants that stand before you in the sense that Mr. Ahsani is a UK citizen who lives in Monaco and that makes him a

deportable alien and because of the Bureau of Prisons rules for deportable aliens, generally he's not eligible to go to a minimum-security facility or a camp or a halfway house. Even after he finishes his sentence, then he faces a deportation proceeding. So he has worked with the government, Your Honor. He's been trustworthy in terms of working with the government in terms of reporting on a daily basis. He has his passport. He checks in with the government. I think that shows the high degree of trust the government has in him as does the fact that the government said they would not ask for immediate incarceration if a custodial sentence were offered.

I would like to say, Your Honor, that it was Sammy Ahsani's plan, it was his goal to wean the company away from these illegal payments. The advisory services where most of this activity took place last earned money in, I think, 2013 and was basically divested in 2015. So by 2016 when the investigation began, it was Sammy's vision for the company that it would be an infrastructure company and that it would combine the western technology.

I would also like to point out that Sammy has pled guilty to or admitted the obstruction that was described by Mr. Moody, the destruction of documents. But one thing that doesn't address is that Mr. Ahsani kept a copy, unknown to anybody else, Your Honor, of the key documents and the key recordings and that Mr. Ahsani provided those key documents and

those key recordings to the government.

Our argument would be based upon what was presented earlier to Your Honor, based upon the 14 months he spent away from his family, based upon the remorse that was recognized by the presentence officer in the presentence report and based upon all the factors that have been described to Your Honor here and earlier that a sentence of probation is warranted in this case. As I said, if you take the 15 months the government is seeking and you balance that against the 14 months we've talked about, four in Italy, ten in DC, I think that sufficiently addresses an issue -- and there's no issue of specific deterrence here. Nobody on either side of the table here thinks that there's an issue of specific deterrence here. So I know the Court has to balance with how it fits with other defendants; but I would just argue that given the 14 months, given all the other factors the Court is aware of, this case is lifted out of the ordinary cases. It's different from the other cases.

THE COURT: Mr. Ahsani, would you like to say anything, sir?

THE DEFENDANT: Thank you, Your Honor, for giving me the opportunity to speak with you.

Your Honor, bribery has been wrong since the days of the New Testament. It corrupts not just the marketplace, it corrupts the minds and thinking of those who take part in it;

and whatever the specifics of my particular circumstances, the fact is that as a 32-year-old adult at the time, I made an active choice to join and partake in a criminal conspiracy to bribe foreign officials in developing countries. This was wrong then, it remains wrong today; and as I've admitted in full, I made a very poor life choice which caused investigations into my conduct that have had devastating effects on my life and, more importantly, on those closest to me.

Beyond the loss of my reputation, the loss of all my savings and equity in the business, the loss of most aspects of my life that I knew back then, beyond those material things, the most important consequence was on my children and my relationship with each of my children. The first duty of any responsible father is to protect his children. I'm afraid that aged 4, 7 and 9, as they were at the time, my actions forced an adult weight onto my children's shoulders, a weight that forever fills me with guilt and shame because I was unable to protect them from a revolution in their lives which they had nothing to do with, but which has affected each of them profoundly. I felt this especially keenly during my absence of 14 months, thousands of miles away from them whilst I was working with the government; and that is the reason, Your Honor, beyond all the many other good reasons why I can assure you with every sinew and cell in my body that you will never,

ever see me standing in front of you in your courtroom again for any crime, let alone that of bribery.

When life hits you sideways or, as I like to see it, when God decides to actively intervene in your life, he shakes you and forces you to re-examine your life and the direction it is going in. I believe he does this for a reason and with love because there are indeed many silver linings to his intervention. He put a huge mirror up to my life and shone a glaring light on to my actions; and I mean much more than a superficial media glare, rather a deep and fundamental reckoning which compelled me to think about my place and my role in this world and in the lives of those around me.

Left physically alone, separated from the bonds that tie, I was given the opportunity to be released from my past and just as it is a choice to take part in something, I believe it is also an active choice to leave it and for that I am truly grateful to have been given a second chance to show Him, as well as the U.S. government, just how serious and committed I am about leading a better life, a life where for the past five years I have purposely, intently and happily bent over backwards and taken on numerous risks to assist the U.S. In fact, my whole future orientation is set around continuing to help others see the benefits of cooperation and to find alternative resolutions to their issues. This is because I see myself as Exhibit A for the benefits of true cooperation, and

1 for that opportunity I am truly grateful. 2 Thank you. 3 THE COURT: Thank you, Mr. Ahsani. 4 Anything either side wants to add? 5 MS. ELMILADY: Your Honor, we just have a money judgment before Your Honor for 1.5 million. 6 7 THE COURT: Okay. 8 MS. ELMILADY: And it's agreed upon. 9 THE COURT: Any objection, Mr. Coggins, to me signing that? 10 11 MR. COGGINS: No, Your Honor. 12 MS. ELMILADY: Thank you, Judge. 13 THE COURT: All right. MR. COGGINS: Your Honor, we do have a recommendation if it's okay with the government. I've talked to the prosecutors, and we would recommend the camp at Beaumont if that would meet with the Court's --

THE COURT: Okay. I'll recommend that.

MS. ELMILADY: The Bureau of Prisons did say if Your Honor puts it in the judgment sentence, they can adhere to it.

THE COURT: Then I will put in the camp at Beaumont.

Upon release from imprisonment, the defendant shall be placed on supervised release for a term of one year as an added measure of deterrence. If not deported, the defendant shall report in person to the probation office in the district to which he's released or to the official designated by the Department of Justice within 72 hours of being released from the custody of the Bureau of Prisons. The defendant is hereby permitted to return to his home and home country to serve this term of supervised release. While on supervised release he shall not commit another state, federal or local crime; he shall comply with the standard conditions adopted by this Court with the exception of the residency, which I have just addressed; abide by any mandatory conditions required by law and shall comply with the following additional conditions.

He shall not possess a firearm, destructive device or other dangerous weapon. He shall not illegally

possess a controlled substance and shall refrain from unlawful use of a controlled substance. He shall cooperate with the collection of a DNA sample if it's authorized by statute and he's not to enter the United States illegally. The Court finds the defendant does not have the ability -- or is not required to pay a fine given that I've signed the money judgment; but I do impose the special assessment of \$100. Counsel, any objection to Mr. Ahsani remaining free under the same terms and conditions he's been under? No objection from the government. MR. MOODY: THE COURT: All right. Good luck, Mr. Ahsani. MR. COGGINS: Thank you, Your Honor. THE DEFENDANT: Thank you, sir. THE COURT: We stand adjourned. THE MARSHAL: All rise. (The proceedings were adjourned.) COURT REPORTER'S CERTIFICATE I, David S.
