PETITION FOR REVIEW

Petitioners Bret Pallotto and the Centre Daily Times ("CDT") hereby file this Petition for Review under Act 22 of 2017, 42 Pa.C.S. §§ 67A01 *et seq.* ("Act 22"), which permits any member of the public and the press to request video and audio recordings created by law enforcement agencies and further allows a right of appeal in the event access is denied. In support of their appeal, Petitioners aver as follows:

PARTIES

- 1. Petitioner Bret Pallotto is an adult individual who is employed as CDT's crimes and court reporter. His business address is 221 W. High Street, Suite 1300, Bellefonte, PA 16823.
- 2. The Centre Daily Times is a print and online news outlet covering Centre County. Its business address is 221 W. High Street, Suite 1300, Bellefonte, PA 16823.
- 3. Respondent Pennsylvania State Police ("PSP") is the entity that denied Petitioner's request for body-worn camera footage per 42 Pa.C.S. § 67A06(a)(2). Respondent's headquarters are located at 1800 Elmerton Avenue, Harrisburg, PA 17110.

JURISDICTION

4. Respondent is a state agency located within Dauphin County; the request denial came from an office based in Dauphin County; therefore, the Court has jurisdiction over this matter. *See* 42 Pa.C.S. § 67A06(a)(1) (providing right of appeal to court of common pleas).

STATEMENT OF FACTS

- 5. On August 19, 2025, U.S. Immigration and Customs Enforcement ("ICE") conducted an immigration enforcement action on Interstate 99 near Bellefonte, Centre County, PA. See Bret Pallotto, 26 Workers Detained by ICE in Centre County advocacy groups say. What we know, Centre Daily Times (August 22, 2025), https://www.centredaily.com/news/local/community/article311779674.html.
- 6. Respondent has acknowledged that troopers employed by PSP were present at the time that ICE was detaining individuals on August 19, 2025. *Id.*; *see also* Bret Pallotto, *ICE confirms 24 arrests on highway in Centre County, though questions remain*, Centre Daily Times (August 28, 2025), https://www.centredaily.com/news/local/community/article311848252.html; Bret Pallotto, 'Silence and secrecy.' PA lawmaker raises concerns about ICE arrests in Centre County, Centre Daily Times (August 28, 2025), https://www.centredaily.com/news/local/community/article311888204.html.
- 7. Bret Pallotto is a reporter covering courts and crime for the Centre Daily Times.

 Mr. Pallotto has been the primary reporter covering the August 19, 2025, ICE immigration enforcement action.
- 8. On August 29, 2025, Mr. Pallotto sent to PSP via certified mail a request pursuant to 42 Pa.C.S. §§ 67A01 *et seq.* seeking PSP troopers' body camera footage capturing the August

19, 2025, immigration enforcement action incident. *See* Request and Declaration of Bret Pallotto (attached and incorporated herein as **Exhibit A**).

- 9. On September 8, 2025, PSP issued a written denial of Mr. Pallotto's Act 22 request. *See* September 8, 2025, PSP Letter (attached and incorporated herein as **Exhibit B**). The denial letter, signed by William A. Rozier, J.D., the Agency Open Records Officer, stated that the recordings sought by Mr. Pallotto's Act 22 request "is not an audio/video recording made by or associated with an incidnet [sic] investigated by Pennsylvania State Police. You may seek information on obtaining audio/video recordings by contacting ICE." *Id*.
 - 10. The letter contained no further bases of denial and no instructions for appeal. *Id.*

ARGUMENT

- 11. Petitioners incorporate by reference paragraphs 1–10 as if fully set forth herein.
- 12. Act 22 provides a statutory right of access by which the public may request and review police body camera footage to foster accountability and public trust in law enforcement. See generally 42 Pa.C.S. §§ 67A01 et seq.; see also Press Release, Commonwealth of Pa., The Shapiro Administration Announces Pennsylvania Capitol Police Fully Implement Body Camera Technology (Mar. 13, 2023), https://perma.cc/E8VA-3HF4 (discussing how body cameras "add[] another layer of transparency, accountability, and safety for both the public and our officers"); Press Release, Governor Tom Wolf, Wolf Administration Receives Federal Grant for State Police Body-Worn Camera Pilot Program (July 7, 2017), https://perma.cc/982V-UCC9 ("[B]ody-worn cameras strengthen police accountability, prevent confrontational situations, and improve evidence documentation."); Pa. S. Legis. J., 201st Gen. Assemb., at 461 (May 9, 2017), https://perma.cc/99TE-HBT9 ("[W]e want to become more open and transparent with respect to body cameras as we move forward.") (statement of Senator Jay Costa); Press Release, Pa. State

Police, PSP Completes Rollout of Body-Worn Cameras Ahead of Schedule (Apr. 10, 2025), https://www.pa.gov/agencies/psp/newsroom/psp-completes-rollout-of-body-worn-cameras-ahead-of-schedule ("As the rollout of body cameras comes to completion, I'm thrilled we will see improved transparency with exchanges between officers and civilians.") (statement of Senator Devin Robinson).

- 13. Pursuant to 42 Pa.C.S. § 67A06(e), this Court should grant this Petition and order disclosure of the requested footage if it determines that Petitioners have established the following by a preponderance of the evidence:
 - i. Petitioners' request was not denied under 42 Pa.C.S. § 67A04; and
 - ii. The public interest in disclosure or the interest of Petitioners outweighs the interests of law enforcement or an individual's interest in nondisclosure.
- 14. "A preponderance of the evidence standard, the lowest evidentiary standard, is tantamount to a more likely than not inquiry." *Carey v. Pa. Dep't of Corr.*, 61 A.3d 367, 374 (Pa. Commw. Ct. 2013) (citation and internal quotation marks omitted), *supplemented by* No. 1348 C.D. 2012, 2013 WL 3357733 (Pa. Commw. Ct. July 3, 2013).

Petitioner's Request Was Not Properly Denied Under § 67A04.

- 15. Per Section 67A04(a) of the Act, a law enforcement entity may deny an Act 22 request *only* if the relevant audio or video footage "contains potential evidence in a criminal matter, information pertaining to an investigation or a matter in which a criminal charge has been filed, confidential information[,] or victim information[,] and the reasonable reduction of the audio or video recording would not safeguard" said evidence or information. 42 Pa.C.S. § 67A04(a).
- 16. Here, Respondent does not claim that any footage contains potential evidence, confidential information, or victim information. Ex. B. Instead, Respondent has denied access to

the footage because it asserts the incident was not "investigated" by the Pennsylvania State Police.

Id. This rationale has no basis in the Act. Under § 67A04(a), the question is not whether the agency in possession of the footage "investigated" an incident, but whether release of the recording would impair potential evidence, information pertaining to an investigation, confidential information or victim information. 42 Pa.C.S. § 67A04(a). Therefore, the request was not denied

The Public Interest in Disclosure Outweighs Any Countervailing Interests in Nondisclosure.

- 17. It is more likely than not that the public interest in disclosure of the requested footage, and/or the interest of Petitioners, outweighs the interests of Respondent and/or an individual's interest in nondisclosure.
 - 18. In making its public interest disclosure determination, this Court may consider:
 - i. "the public's interest in understanding how law enforcement officers interact with the public,"
 - ii. "the interests of crime victims, law enforcement and others with respect to safety and privacy," and
 - iii. "the resources available to review and disclose the audio recording or video recording."

42 Pa.C.S. § 67A06(e).

under § 67A04.

19. Here, there is significant public interest in the circumstances surrounding the August 19, 2025, incident. In addition to Petitioners' coverage of this incident, *see supra* ¶¶ 5–6, numerous news outlets throughout Pennsylvania have reported on the arrests. *See, e.g.*, Anne Danahy, *ICE releases limited information on arrests of 24 in Centre County*, WPSU (Aug. 26, 2025), <a href="https://radio.wpsu.org/2025-08-26/ice-releases-limited-information-on-arrests-of-24-in-public interest in the circumstances surrounding the August 19, 2025, incident. In addition to Petitioners' coverage of this incident, *see supra* ¶¶ 5–6, numerous news outlets throughout Pennsylvania have reported on the arrests. *See, e.g.*, Anne Danahy, *ICE releases limited information on arrests of 24 in Centre County*, WPSU (Aug. 26, 2025), <a href="https://radio.wpsu.org/2025-08-26/ice-releases-limited-information-on-arrests-of-24-in-public limited-information-on-arrests-of-24-in-public limited-information-on-arrests-of-24-

centre-county; Jocelyn Bilker, 'They are terrorizing our communities': Activist groups hold press conference on recent ICE action, seizure, The Daily Collegian (Aug. 21, 2025), <a href="https://www.psucollegian.com/news/borough/they-are-terrorizing-our-communities-activist-groups-hold-press-conference-on-recent-ice-action-seizure/article_d870397b-0ee4-4749-9e47-2744918300dd.html; Tristan Klinefelter, Congressman Glenn Thompson comments on recent ICE arrests in Centre County, WTAJ (Aug. 29, 2025), https://www.wtaj.com/news/local-news/congressman-glenn-thompson-comments-on-recent-ice-arrests-in-centre-county/; WJAC Staff, Federal immigration arrests in Centre County praised and critiqued amid community debate, Local 21 News (Sept. 2, 2025), https://local21news.com/news/local/federal-immigration-arrests-in-centre-county-praised-and-critiqued-amid-community-debate.

- 20. This coverage stems from the public's profound interest in better understanding local law enforcement officers' interactions with their communities and with federal law enforcement officers. Justice Brennan recognized half a century ago that members of the news media may "guard[] against the miscarriage of justice by subjecting the police, prosecutors, and judicial processes . . . to the cleansing effects of exposure and public accountability." *Neb. Press Ass'n v. Stuart*, 427 U.S. 539, 587 (1976) (Brennan, J., concurring) (citation omitted). Indeed, "[c]ommentary and reporting on the criminal justice system"—in which police officers play a central role—"is at the core of First Amendment values, for the operation and integrity of that system is of crucial import to citizens concerned with the administration of government." *Id.*
- 21. These principles are echoed today by communities and governments in Pennsylvania and beyond, particularly in light of increased federal immigration enforcement and public debate over what role local law enforcement should play in implementing federal immigration law. See, e.g., Abigail Hakas, Law enforcement agencies are working with ICE to

make arrests in Pennsylvania, WESA (July 8, 2025), https://www.wesa.fm/courts-justice/2025-07-08/pennsylvania-police-law-enforcement-collaborating-with-ice; Kenny Cooper, Cheltenham residents urge officials to adopt immigrant welcoming policy, WHYY (Sept. 23, 2025), https://whyy.org/articles/cheltenham-pennsylvania-immigrant-welcoming-policy/.

- 22. Pennsylvania State Police policy prohibits PSP from assisting federal immigration officials. *See* AR 7-14, Enforcement of Civil Immigration Law: Arrest/Detention or Death of Foreign Nationals, § 14.01 (Feb. 28, 2022), https://www.pa.gov/content/dam/copapwp-pagov/en/psp/documents/regs-manuals/AR%207-14.pdf.
- 23. Eyewitnesses reported seeing PSP officers assisting in the August 19, 2025, incident. See Jocelyn Bilker, 'They are terrorizing our communities': Activist groups hold press conference on recent ICE action, seizure, The Daily Collegian (Aug. 21, 2025), https://www.psucollegian.com/news/borough/they-are-terrorizing-our-communities-activist-groups-hold-press-conference-on-recent-ice-action-seizure/article_d870397b-0ee4-4749-9e47-2744918300dd.html. PSP has claimed in a statement to Petitioners that "multiple troopers made stops and inquiries after encountering this ICE operation, and all left after being told everything was OK." This statement, an email from Communications Director Myles Snyder in response to an inquiry from CDT, is attached as Exhibit C.
- 24. The information released to date about the August 19, 2025, incident leaves many important questions unanswered. Access to the requested footage will give the public and the press information to better understand the role that Pennsylvania State Police played in the arrest of 24 people in Centre County and whether that role was in accordance with Pennsylvania State Police policy.

- 25. Finally, PSP has "the resources available to review and disclose the audio recording or video recording." 42 Pa.C.S. § 67A06(e).
- 26. Law enforcement officials in Pennsylvania routinely release body camera footage proactively or in response to an Act 22 request. For instance, in the wake of massive public outcry over the fatal police shooting of a 27-year-old Lancaster man, Lancaster police released footage from the officers' body cameras. See Lori Burkholder, Lancaster Police Video: Man Fatally Shot Ran Officer While Holding WGAL8 14, 2020), at Knife, (Sept. https://www.wgal.com/article/lancaster-police-body-cam-video-shooting-man-armed-with-knifericardo-munoz/34009627. Similarly, police in Philadelphia, in consultation with their elected District Attorney, released body camera footage showing the death of a man at the hands of law enforcement. Max Marin, 'Shoot him': Body camera footage shows officers who shot and killed Walter Wallace Jr., WHYY (Nov. 4, 2020), https://perma.cc/CG6N-A5FL. In Lancaster County, a recent Act 22 appeal was voluntarily dismissed after the City of Lancaster agreed to produce more than 16 hours of footage depicting law enforcement clashes with protesters. Notice of Voluntary Dismissal, Meko v. City of Lancaster, No. CI-21-00277 (Pa. Ct. Com. Pl., Lancaster Cnty. Oct. 4, 2021). And in Cumberland County, another Act 22 matter was dismissed after the Cumberland County District Attorney agreed to permit Patriot-News/PennLive reporter Charles Thompson to view body camera footage of the fatal police shooting of Roger Wayne Ellis. See Notice of Voluntary Dismissal, *Thompson v. Cumberland Cnty.*, No. 2022-03057 (Pa. Ct. Com. Pl., Cumberland Cnty. July 28, 2022), https://www.rcfp.org/litigation/thompson-v-cumberland- county/.
- 27. Indeed, modern technology renders release of the audio and video footage Petitioners seek here—along with any necessary redaction or blurring—routine and

straightforward. For instance, a Lancaster County reporter's Act 22 request was fulfilled by a local police department within five days of submission of the request. Carter Walker, *Lancaster County president judge at traffic stop: 'You better check the registration on this plate soon' [video]*, LancasterOnline (June 16, 2019), https://perma.cc/8GKB-Q5AZ. In Harrisburg, law enforcement released video of an incident involving police interacting with a community activist within mere days. *See* Christine Vendel, *Police release body cam video of Harrisburg activist's arrest after she calls for officer to be fired*, PennLive (Nov. 12, 2020), https://perma.cc/U5AP-TCWH.

- 28. Relatedly, courts across the country have recognized that in lieu of "categorically ban[ning] disclosure of all investigatory" records, agencies need only employ "ways to limit rather than wholly exclude the release of the records sought so as to address any reasonable concerns," such as "blurring portions of video that show [witnesses'] faces, and possibly altering their voices," *Courier-J., Inc. v. Shively Police Dep't*, No. 2021-CA-1120-MR, 2022 WL 16842295, at *7 (Ky. Ct. App. Nov. 10, 2022) (involving request by a Kentucky newspaper); *see also Stahl v. Dep't of Just.*, No. 19-CV-4142 (BMC), 2021 WL 1163154, at *7 (E.D.N.Y. Mar. 26, 2021) (opining that because editing of audio-visual material to satisfy public records requests "is routine and inexpensive, an agency cannot credibly claim that it lacks access to this technology").
- 29. So too here. Accordingly, Respondent should disclose the requested footage, with any necessary redactions, per the clear tenets of Act 22.

WHEREFORE, Petitioners ask this Honorable Court to:

- 1. Grant this Petition for Review and order access to the requested records; or
- 2. In the alternative, grant this Petition for Review and establish a briefing schedule or set a date for an evidentiary hearing; and
- 3. Grant such other relief as may be appropriate.

I, Bret Pallotto, declare as follows:

- 1. I am the crimes and court reporter for the Centre Daily Times, a print and online news outlet covering Centre County.
- 2. My business address is 221 W. High Street, Suite 1200, Bellefonte, PA 16823.
- 3. I have personal knowledge of the matters stated in this declaration.
- 4. A critical component of my work as the crimes and court reporter is obtaining and reviewing public records through the use of state public records laws, as well as obtaining judicial records from courts.
- 5. Following the August 19, 2025 arrests of 24 individuals by federal Immigration and Customs Enforcement (ICE) officials on Interstate 99 near Bellefonte, Centre County, PA, I sought to provide our readers with more information about what happened.
- 6. On August 29, 2025, I sent via certified mail addressed to the Pennsylvania State Police, Bureau of Records, 1800 Elmerton Avenue, Harrisburg, PA, 17110 a Law Enforcement Recording Request Form (the "Form"). I mailed the Form from the USPS Office at 132 N. Allegheny St., Bellefonte, PA 16823. I did not maintain a copy of the certified mail
