#### MOTION TO VOLUNTARILY DISMISS APPEAL

Pursuant to Supreme Court Rules 343 and 361, Plaintiff-Appellant People of the State of Illinois hereby moves to voluntarily dismiss the appeal in the above-captioned cause. In support, the People state as follows:

- 1. On October 14, 2011, the People filed a notice of appeal to this Court from the September 15, 2011, order of the Circuit Court of Crawford County dismissing five charges of eavesdropping against defendant Michael Allison on the ground that Illinois's eavesdropping statute, 720 ILCS 5/14-2 (West 2008), is unconstitutional. *See* Sup. Ct. R. 603.
- 2. The People's opening brief has not yet been filed. It is currently due on or before March 27, 2012.
- 3. After consultation between the Office of the Attorney General and the Crawford County State's Attorney, the People have determined that they no longer wish to pursue this appeal.
  - 4. Accordingly, the People hereby move to voluntarily dismiss the instant appeal.

5. Should this motion be denied, the People request in the alternative a thirty-five day extension of time, from March 27, 2012, to and including May 1, 2012, in which to file their appellant's brief.
